Minutes – Service Symposium –March 12-15, 2009 – Crowne Plaza – Tampa, FL

I attended the Symposium put on by our Region on the weekend of March 12-15th. From what I understand there were over 400 attendants, which makes this Symposium the best attended so far. There were addicts there from Europe, Israel, The Bahamas, Central America, Puerto Rico and a large portion from various States, including obviously Florida.

I participated in the following Workshops:

Worldwide Fellowship Development which took place on Friday – this presentation put on by NAWS, dealt with the growth of our Fellowship throughout the world. They discussed some of the obstacles in starting meetings in some places, and they also talked about some of the miracles that are taking place in these countries like Iran for example. On a sour note the statistical evidence presented portrayed a decline in the overall meeting attendance/growth for the United States. Some of the factors presented were the emergence of the Internet as a tool for Recovery, also a bottoming out effect from the booming 80's thru the 90's where we witness the greatest growth of our Fellowship in the U.S.

Building our Technology Infrastructure – One byte @ a time – This was by far the most interesting and attended out of all the workshops. It comprised 3 sessions for a total of 5.25 hrs, After the first session, they had to find a bigger room due to the # of attendees. Never before has a program like this been done as successfully as this was anywhere in NA. I only was able to attend the first session. Chris M. from NY led the presentation along with Chris D. from NC. It was an introduction to the Internet, obviously; from our perspective. Information Technology covers a wide spectrum of tools and services which can be utilized effectively to bolster our ability to carry the message to the addicts who still suffers and for whatever reason is not able to get to a meeting. It can also harm if used improperly, and by that we generally are talking about using this technology without the guiding Spiritual Principles embodied in the Steps, Traditions, and Concepts.

How to be a more Effective RCM - This was also a very well attended Workshop. Facilitated by NAWS, I was asked by Ron H. (World Member) to share my experience regarding my role as RCM. (Was not expecting it , Did the best I could) This session covered what are the required skills/qualities an RCM ought to have in order for them to effectively carry out their role. In recent years the Fellowship has been witnessing a Cultural Shift from delegating authority to assignment, thus why the shift in titles from ASR to RCM, RSR to RD and HP/FD. Ron M. (World Member) gave a discussion of what effective services are and I found it quite interesting. He talked about what is called “Necessary vs. Sufficient” conditions and went on to explain how these conditions are defined based on the Steps, Traditions, and Concepts, i.e. If we were to look at an issue with lets say the Area providing or not providing a particular service, this model of necessary vs. sufficient can be applied. If it requires all 3 elements, i.e. the Steps, Traditions, and Concepts in the evaluation, then one is looking at a sufficient, not necessary condition. This is front page stuff, in the same level as CDM (Consensus Decision Making) which I'll talk about next.

The Death of Robert's Rules of Order – CBDM – facilitated by Jimi S. from Wash D.C. – Another well attended session. This model has been around for a few years, currently NAWS uses it, Sacramento Region, a host of Areas throughout the country, and some Areas here in Florida are using it. CBDM or CDM as is popularly known stands for Consensus Decision Making. Consensus is the process by which a common mind of the meeting is sought about the wisest way forward on a particular issue at the time. The problem with Parliamentary procedures is that it creates a competitive dynamics which is non-spiritual. It generates an atmosphere of winners vs. losers. It appears to be contradictive in trying to reach/obtain God's will and/or (Group Conscience)

The 6th Concept talks about “Collective Conscience” – CDM is less confrontational and more agreement based. Cooperative dynamics which is more conducive at the development/evolution to a solution. What we are talking about is “Proposed Ideas vs. a Motion.” This warrants further research, evaluation,

discussion and hopeful insertion.

Recovery Meetings – Fri. night speaker Roy P. from Philadelphia. In 1969 he brought the little white book from California to Philly, 1000 copies were made and distributed throughout the East Coast. He and an AA member started the first NA meeting east of the Rockies at Eagleville Hospital. It was quite insightful to hear Roy share about how things were in those days. Recovery under the sun touches on some of the areas Roy shared. Sat. night International Speaker Meeting – The room was full for this one. Over 500 chairs were set up. We listened to Rose from Amsterdam, Jose Luis from Puerto Rico, Pierrot from Montreal, Laura from Costa Rica, Eddie from the Bahamas, and Shmuel from Israel. They pulled this off in 1hr 10 mins.

Sunday - RSC

Due to the Symposium we did not have the Area support meeting nor Fellowship Development. My report was not inserted onto the Regional Minutes. Don't know if I failed to properly transfer the data onto the flash-drive or something else happened.

The following positions are open: PR Resource Coord., 1 RSO Board RSC Elect and FRC Board RSC Elect, there were no nominations. On old business the two house keeping motions which dealt with the mileage reimbursement and reimbursement in general for persons selected by HRP both passed. 2 Areas abstained.

There were some rumors coming out of Tampa (Fun Coast) of the possibility of the creation of a new Region. (Splitting from Florida Region) RCM from Fun Coast stated some factions are evaluating the possibility of submitting a motion.

The RD shared some facts about first the Moratorium on seating of newly formed Regions. I don't recall the length of time involved, but I know it is quite some time before a new Region would sit at the WSC. And then there are obvious monetary constraints. A Region needs anywhere from \$25 – \$30K to be viable. I'm sure we will hear more on this in the coming weeks/months.
