They're discussing having some 3 panel workshops and men and women rap. Fundraising and Entertainment reported they made on April 8 \$112.80 after paying for the DJ \$75 they made 37.80 and on April 22 they made \$157.87 after paying for the DJ they brought in \$82.87, which was put back into the seed money. They've \$253.31 in their seed money at this time. The t-shirts that they ordered were pick up and they've only 6 left. They had a Speaker Jam on May 7 and it went well. We have a softball Tournament and a Victory Dance on June 4, meeting a 8pm and a dance 9pm-12am. \$3pp and \$5 at the door, it'll be a 7860 Southside blvd. Flyers will be out soon for upcoming events. Registration reported they're discussing finances, and what will go into the registration packets and also the letter inviting members back to FCACNA XI and the upcoming fun raising events. They had a Pre-registration for \$10 at the event on May 7. Hotel and Hospitality are discussing on what they're going to have in the Hospitality room. They'll have sign-up sheets for volunteers for the GSR to take back to their groups. Merchandising reported that they're selling Pre-Convention shirts and water bottle

right now. The shirts are \$15 and the bottles are \$5. They brought the Pre-Convention shirts for grand total of \$1,087.00 and the bottle water for \$465.00. Art and Graphics is going well. No motion to ASC
