The First Coast Area Service Committee (ASC) met Saturday, October 8th, 2011 at St Luke's Hospital Roger Main Room 370 | 4201 Belfort Road Jacksonville, Florida.

The Vice-Chair called the meeting to order at 11:00 a.m. The meeting opened with a moment of silence followed by the Service Prayer. NA members read the 12 Traditions and concepts.

Janell S. NA member addressed ASC and read letter

To The First Coast Area of Narcotics Anonymous:

I, Janell S, am writing this letter with several concerns. When I first got clean in this Area, I was guided by several experienced members. I was told what service commitments that I would do and when to do them; however, I was also shown how to do the commitment. I was told that I could not quit and I had to fulfill that duty until my time was up. I was educated on what to do and not to do because this is what we do in Narcotics Anonymous. I was also told by my sponsor or home group members if I was not ready to do a commitment. They would tell me that I had not learned enough to serve effectively. The guidance I received in this fellowship was indispensable, but there were several things that I had to have to serve. I had to be honest, open-minded, willing, and humble.

As I have continued to come around, I have found that we have ignored most or all of these qualities in our trusted servants because we are unwilling or unable to step up ourselves. We allow suffering addicts to struggle in commitments only to find themselves jeopardizing their recovery. These addicts we place in commitments are inexperienced, unprepared, unqualified, arrogant, unwilling, and most of all spiritually broken. We expect them to serve with integrity, honesty, and humility when they do not have the tools to do so; and when they fail, we are surprised, or we break them even more with gossip. And I am guilty of this myself. We do not love these addicts enough to say not now work on you.

We, and I say we, will not stand for the truth and save a life. We make decisions on our Area floor based

on how others will see us rather than how it will affect the addict to come. Our Area is now based on personalities rather than principles.

I come to this Area asking that you stand on the truth. I went to my home group several months ago standing on some principles, and now months down the line the same behavior is still plaguing our Area. I was accused of using my home group as my voice. I stood for the truth, and the truth is the truth. Before I did anything, I prayed about it, read about it, talked to my sponsor, and sought guidance from an experienced member. I have come to accept that by doing the right thing that I may have to stand alone, but I am willing.

My request to the First Coast Area and all of its members is to seek guidance, get with your sponsor, consult your Higher Power, and ask for the same courage and the willingness to do the same and stand. We do not have to lose any more members because we did not tell them the truth; we did not love on them enough; and we did not say enough was enough. We are here to ensure that the addict coming has a place to come to, but most importantly, we must take care of the ones here; even if it means making the hard decisions. Let us love them to life; rather than ignoring them to death.

COMMENTS, PROBLEMS, QUESTIONS: As of today Treasurer couldn't give us an accurate report. It will be forthcoming. Hotel and Hospitality reported we met our room block with an additional 38 rooms, we got the meeting spaces free with all other perks that was agreed on. They also want to thank all home groups and member who donated to the hospitality room. They will be turning over \$128 with receipts that was left after all purchases. They also encounter some problem with the hotel to opening the doors for Registration Chair and Merchandising Chair along with workshops doors. Also issues with Audio at the beginning of the Main Speaker Saturday night so sound for about 15 min. until hotel audio person came and fixed. Also we had to adjust because the speaker was shouting and people were complaining so audio was lowered so when the countdown was done we couldn't hear. These are things for the next H&H need to be up on for the next convention. Check audio before meetings make sure it's working. Fundraising and Entertainment reported is over they're turning over \$941 to the treasurer.
